B. Terms of Reference (TOR) of AEFI Expert Review Commttee:

- 1. Advisory role in confirming the causality assessment of selected investigations and in determining causality when not established with confidence by the investigation team.
- 2. Review the invetigation reports of serious AEFI, assess and classify the unresolved cases of AEFI;
- 3. Provide technical advice on strengthening the AEFI surveillance system by reviewing AEFI surveillance data.
- 4. Monitor reported AEFI data for potential signals of previously unrecognized Vaccine-related adverse events and make recommendations for further investigation.
- 5. Advise EPI HQ, NRA/NCL (DGDA) at times of crises/emergency and assist the AEFI investigation team if needed.
- C. The Committee will meet quarterly and when needed. The Chairperson can co-opt members for the committee if needed.

D. This Notification has the approval of competent authority and will take into effect immediately.
